² The Independence Visitor Center in Philadelphia was built on land owned by the Federal government and administered by Independence National Historical Park, a unit of the National Park Service (NPS). The NPS has contracted with a private entity, Independence Visitor Center Corporation, to operate the facility, and the NPS has supported the Visitor Center with Federal appropriations of \$6.4 million since 2001 that has primarily been disbursed with annual appropriations of \$850,000.00. The Visitor Center is approximately 50,000 square feet in size, and is marketed as the "largest facility of its kind in the world." The Visitor Center was designed and intended to serve as a tourism hub and the primary point of orientation and visitor services for the Park and surrounding environs. The Visitor Center is the only official on-site ticketing location for visitors to pick up tickets to Independence Hall. The Visitor Center promotes the notion that that visitors need to "Start at the Center" in order to experience the "best way to see Philly."
